# 4. Updates on Joint Committee Meeting 29 November 2024 and other matters – Steve Purdham & Philip Cox

4.1. The Board received an update on relevant discussion from the recent Local Authorities Joint Committee meeting covering devolution, the Cheshire and Warrington response to the Government's recently-announced Modern Industrial Strategy and the Business Advisory Board Network.

#### 4.2. Devolution:

- Members were updated on devolution. The forthcoming Devolution White Paper will set out the Government's thinking and will be key to further discussions about the opportunities it might offer to C&W
- A Devolution Summit is planned for Tuesday 21<sup>st</sup> January at The Park Royal Hotel & Spa, Warrington

#### 4.3. Modern Industrial Strategy:

- Following the previous BAB meeting, members were thanked for their contributions to developing a response on behalf of Cheshire and Warrington to the Government's Modern Industrial Strategy Consultation.
- The response has been submitted to Government and the consultation has now closed. Updates will be provided at future meetings.

## 4.4. Business Board Network:

- The Business Board Network (BBN) has been formed to support the needs and priorities
  of the business and economic boards being established in local authorities tasked with
  driving local economic growth and delivering Local Growth Plans under Chair, Mark
  Bretton and Chief Executive, Mark Livesey.
- Currently membership numbers 28 boards. Although each sub-region will form a board that they feel meets their local needs, they are broadly similar in structure and purpose to the C&W BAB.
- Future funding for the BBN is uncertain since at the Budget on 30 October 2024, government announced its intention to consult on ending funding for Pan-Regional Partnerships. This consultation ended on 16<sup>th</sup> December and the outcome is awaited.

#### 5. Get Britain Working: DWP White Paper - Pat Jackson

- 5.1. Members received a briefing on the context and content of the recently published (26<sup>th</sup> Nov) 'Get Britain Working' Government White Paper.
- 5.2. Observations from members included:
  - Need to close some of the loopholes allowing long-term claiming of benefits.
  - Several comments seeking to understand the data better, including demographics and the reasons behind economic inactivity.
  - A suggestion to understand what businesses need and focus training for older people in those areas
  - Young people require support to become more work ready
  - Suggestion that older people who have voluntarily retired could be encouraged to act as mentors for young people
  - The BAB Community and Employment working group is looking into how local support provision may be better joined up, but finding that this is not an easy task as offers and providers change frequently
  - Need for additional provision training softer skills such as employability and communication in addition to specific specialised technical skills

## 6. The Economy in C&W's Rural Areas – Sarah Callendar-Beckett

- 6.1. Members received a briefing on the rural economy in Cheshire and Warrington, including:
  - The rural economy is about far more than just farming with increasing diversification providing leisure, housing and business parks.
  - There is a lack of data about the rural economy.
  - Transport links are poor meaning that rural residents are hindered from contributing to the economy.
  - Broadband coverage has improved in recent years but mobile phone network coverage
    is very poor. This is a key enabler of remote/hybrid working and adoption of mobile
    technologies and therefore limits rural businesses and adds considerable costs to
    overcome. Suggestion that network providers should be required to address mobile
    blackspots as a condition of expanding networks.
  - Large venues in rural areas require large, sometimes seasonal workforces and rely predominantly on parents of young people to enable work in these locations.
  - There is a Rural Strategy Group which communicates with Local Authorities and the private sector to support the development of the rural economy. This group has recently re-framed its terms of reference and is keen to engage with the BAB.

## 7. BAB Working Group Updates

7.1. Members received updates from the leads of each of the BAB working groups, highlighting early emerging themes as follows:

#### 7.2. Net Zero

- Skill gaps are an issue in almost all areas, including future skills.
- Need to link rural economy issues to rural CO2 emissions.
- Consider renewal of emphasis on nuclear sector as an enabler of net zero.
- The group is making links to stakeholders in LAs, ECW, etc, and prioritising sub-topics with a view to assembling a 'focus pack' on key areas in Feb and input into Local Growth Plan in March.
- Further details are contained in the Net Zero group presentation slides, which will be circulated.

## 7.3. - Community & Employment (Skills)

- Need for a sub-regional digital hub which signposts effectively and easily where information is on skills / career advice / jobs etc.
- Encourage businesses to engage more with education to solve long term recruitment problems.
- Delivering skills training is hindered by lack of instructors and instructors with industry knowledge. We have to solve this bottle-neck.
- Digital skills in context training to improve job-readiness, inclusion, upskilling. Adaptability for evolving job roles.
- Need to foster a "culture of lifelong learning and adaptability.
- Potential to promote 'AI fluency' as a key benefit for C&W

#### 7.4. Sectors and Investment (Funding)

- 3 priority areas funding, inward investment and productivity.
- Develop a ECW funding 'eco-system' equivalent to other local CA's.
- Develop an ECW 'Agency' to handle cross sector Inward Investment enquiries.
- Our offer and digital presence is weak compared to other regions and we are too dependent on developers attracting businesses into their facilities
- Productivity Increase within businesses and also efficiency enabling infrastructure such as transport links.

#### 7.5. Infrastructure

- More collaboration between LAs
- New housing targets will be challenging
- Anecdotal evidence points to a shortage of light industrial and light manufacturing space, further data needed
- Ensure full involvement from C&W in strategic rail projects, e.g. Liverpool-Manchester
- Advocate for EV infrastructure and public transport improvements
- Improvement needed when it comes to high-speed internet and 5G coverage
- Consider planning reforms to enhance collaboration & speed processes

#### 7.6. Observations from members included:

- Constraints on energy networks are holding back development and progress towards net zero
- Need to maintain the importance of and support for the export of physical products alongside digital and services
